A VILLAGE SIGN FOR FRANT ON THE EXACT SAME SITE/POSITION OF THE
ORIGINAL ABERGAVENNY ARMS SIGN ADJACENT TO THE LARGE CAR
PARKING AREA.

Cllr Crookshank expressed disappointment that previous potential designs, such as including maple leaves to acknowledge the link between Frant and Ottawa, were not reflected in the submitted plans. It was **agreed** to recommend **REFUSAL** on a number of grounds:

- no justification as to the need for a village sign;
- potential for visual clutter, particularly with the provision of the pedestrian crossing and lighting immediately adjacent to the application site;
- harm to the surrounding Conservation Area, listed buildings and AONB; and
- the village sign would bear no relationship to the Grade II listed Abergavenny Arms.

ADVERTISMENT CONSENT FOR 4 NO. FLAGS AND FLAGPOLES, AND
HOARDING-MOUNTED ADVERTISEMENT FOR SITE.

Councillors considered that the hoarding-mounted advertisement was acceptable but that the 4 no. flags and flagpoles were unnecessary and would cause harm to the surrounding, very rural character by virtue of their number, positioning, height and design. It was thus **agreed** to recommend **REFUSAL**.
